PREFACE

Indian Microfinance Sector has witnessed phenomenal growth over the past 15 years. Number of Institutions providing microfinance services have gone up from a few numbers to several hundreds. The quantum of credit made available to the poor and financially excluded clients have gone past Rs.30000 crore and number of clients benefitted crossed 30 million as of March 2014.

The Government has created conducive policy framework for Microfinance Institutions (MFIs) to operate in the country. The key move is classifying bank advances to MFIs as priority sector advances. The Government is also in the process of bringing in comprehensive legal framework for microfinance institutions across the country.

The Reserve Bank of India has come out with regulation regulating the NBFC-MFIs. This has provided the necessary legitimacy and impetus to the sector. The MFIs follow the regulation which takes care of client protection issues reported prior to the regulation. Moreover, Self Regulatory Organization (SRO) is also in place to strengthen the regulatory framework for the sector.

This directory is published under the Poorest State Inclusive Growth program (PSIG) supported by UKAID through the Dept for International Development being implemented by SIDBI. The purpose of this directory is to enumerate MFIs that provide at least microcredit in the country. The necessity to the directory arose from the perceptible dilemma of policy makers and the regulator on the level of supervisory attention required regulating the sector in the event of comprehensive microfinance act coming into being. The directory is an attempt to provide list of MFIs actively operating in the country so as to help the policy makers, regulators and others to have a readymade inventory of MFIs in the nation. Also, as moneylenders too started mimicking MFIs in the recent past, the directory would help ring fencing the formal MFIs from being mistakenly identified with such so called 'MFIs'.

The particulars in the directory are mainly self-reported by the MFIs whose names appear in the list. A dedicated online tool was designed and widely circulated to call for particulars from all MFIs in the country.

Similarly, adequate attempt has been made to compile together the scattered lists of MFIs operating in the country as available

with various agencies like industry associations, Small networks operating in different states, lending agencies, etc. The directory team has written to different agencies seeking to share MFI lists, posted the idea of the directory in Sa-Dhan and other websites, and circulated the data-request among UNDP Microfinance Solution Exchange members.

The directory carries the vital information such as Name of MFI, contact details, year of establishment, number and name of the States operating in, products and services rendered, client outreach and loan portfolio. In fact, it was a wishful thinking for the Sa-Dhan team to validate the particulars so received with the help of any secondary data source. Such secondary data set is not readily available. By all means, however, the directory would very well serve the reference purpose and the users may seek further details from the MFIs concerned to meet their specific needs.

The directory carries names of 268 MFIs. The names have been listed out state wise and then 'Tier' (client size) wise under each state. The tier size of MFIs is based on the number of clients served (Tier- 1 > 2.5 lakh; Tier-2 - 0.5-2.5 lakh and Tier 3 - < 0.5 lakh).

We thank all those agencies which helped to compile this directory. The Core Group of institutions working with the Government on Microfinance bill deserves our gratitude for encouragement and idea on the directory. Responsible Finance Forum convened by International Finance Corporation (IFC) has offered valuable advice in refining the content. SIDBI and DFID have provided strategic direction to the directory. This directory would not have been published without the financial support from UKAID and SIDBI under the PSIG project. We thank Mr. Brij Mohan for handholding the Sa-Dhan team on this project.

The directory is the first version to provide the list of MFIs. Obviously the directory work is an ongoing one and the entries will have to be changed with change in composition of players in the market and new information needs to be included. We request the users to offer their valuable feedback to improve the content and format of the directory in future versions.

Definitions

Microfinance:

Micro Finance refers to provision of thrift, credit, and other financial services and products of very small amounts to the poor in rural, semi urban or urban areas, for enabling them to raise their income levels and improve living standards.

MFIs:

MFIs are those organizations, other than banks, providing microfinancial services.

Legal Form:

Incorporation of MFIs under different acts of the country determines the legal form. The common legal forms include Society, Trust, Cooperative, Section 25 Company, Non-Banking Finance Company (NBFC).

Client Outreach:

It denotes the total number of active clients availing the services of an MFI.

Gross Loan Portfolio (GLP):

The outstanding principal balance of loan given by MFIs to clients.
